Each AVCA member school can submit up to three (3) plays per week of competition. **Video files must be no larger than 5 megabytes and should be a Windows Media Player or QuickTime file type.**

Where: All videos should be emailed to playoftheweek@avca.org.

When: Deadline for video submission will be Tuesdays at 11:00 am (ET) for plays from the previous week (Monday-Sunday). The submitted plays for each week will be narrowed down to five, and those five will be posted to the AVCA Web site at 8:00 am (ET) on Thursday to be voted on. Voting will take place on the AVCA Web site and will run from through the following Tuesday at 11:00 a.m. (ET). The Volleyball Market/AVCA Play of the Week will then be announced via press release the following day.

Week 1: The video submission deadline for the week of play during September 14-20 will be Tuesday, September 22 at 11:00 am (ET). Voting will begin on Thursday, September 24 at 8:00 am (ET) and close on Tuesday, September 29 at 11:00 am (ET). The Volleyball Market/AVCA Play of the Week for the week of September 14-20 will be announced on Wednesday, September 30.
