

## **Friday, April 12**

Teams have been divided into four pools of four teams based on seasonal results through Sunday, April 7. All teams will have two pool play matches on Friday. On Saturday all teams will play one pool match to complete pool play and then play one challenge round match to determine Sunday bracket placement.

Championship bracket play will begin on Sunday. The four winners of Challenge Round matches 1 – 4 will advance to the Gold Bracket. The four losers of Challenge Round matches 1 – 4 will move to the Silver Bracket. The four winners of Challenge Round matches 5 – 8 will advance to the Bronze Bracket. The four losers of Challenge Round matches 5 – 8 will move to the Copper Bracket. All teams will have two matches on Sunday. The Division II Champion will be the winner of the Gold bracket.
